LOCAL LIQUOR CONTROL COMMISSION October 14, 2014

The Local Liquor Control Commission held a meeting on Tuesday, October 14, 2014, in City Council Chambers, Room 108 of the Civic Center, 200 S. Illinois Avenue. Chairman Donald Monty called the meeting to order at 7:02 p.m. with the following-named members of the Commission present/absent:

1. Roll Call

Present: Commissioner Carolin Harvey, Commissioner Jane Adams, Commissioner Lee Fronabarger, Commissioner Corene McDaniel, Commissioner Jessica Bradshaw, and Chairman Donald Monty

Also present were Deputy City Clerk Alicia Burtley, City Manager Kevin Baity, and various members of City Staff.

2. Approval of Minutes from September 30, 2014

J. Adams moved, J. Bradshaw seconded, to approve the Minutes of September 30, 2014. DISCUSSION: None. VOTE: Ayes: C. Harvey, J. Adams, L. Fronabarger, C. McDaniel, J. Bradshaw, and D. Monty. Nays: None. Motion declared carried.

3. Discussion of Business Operations including Verification of Compliance with Requirements of Class A2 Liquor License

Daniel Ramirez, 2195 West Alveria Drive, provided and explained documentation to the Commission which exhibited the percentage of monthly receipts attributable to liquor and food sales for the months of March 2014 through September 2014. He explained the nature of La Fogata Taqueria as a restaurant, the hours of operation and cause for flexibility, and how the use of his facility is regulated when events take place.

The Commission inquired about the appearance of the liquor classification A2 establishment, the hours of operation, the responsible party obligated to verify legal entry age requirement, the monitoring and distribution of alcohol during events, and the inclusion of the collected revenue in the percentage requirements. The Commission reviewed the documentation provided and observed the only month close to being under the required fifty-one percent was in the month of April. Most of the months on the requested statement showed alcohol was only accounting for twenty or thirty percent of the sales.

Suggestions consisted of modification of the code pertaining to the restaurant establishment liquor classification to bring clarification and flexibility to all parties involved.

Citizen Comments

Lance Jack, 1026 N. Bridge, owner of Fat Patties, commented on the requirement of certification for employees utilized in the establishment as well as, the responsible party of maintaining the legal entry age on the premises. Assistant City Attorney J. Snyder responded accordingly.

Terrence Walker, 330 Neely Drive, asked if there are any restrictions on the collection of funds at the door. D. Monty addressed the question accordingly.
